#### **Tax Returns:**

At this time (March 20, 2020) The April 15 **filing** deadline has been Extended to July 15, 2020. The IRS will waive penalties and interest for individuals on tax payments for 90 days (July 15) up to a \$1 million liability. This relief also includes estimated tax payments for tax year 2020 that would have been due on April 15, 2020; however, please note, the 2nd quarter estimates are still due on June 15, 2020. There is still no definite guidance from New Jersey or New York regarding filing deadline. We will file state extensions for all clients whose tax returns are not completed by April 15th.
