| Affiliates | <p>Companies related by common ownership and control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none">▪ <i>We have no affiliates.</i> |
| Nonaffiliates | <p>Companies not related by common ownership and control. They can be financial or nonfinancial companies.</p> <ul style="list-style-type: none">▪ <i>We have entered into agreements with non-affiliates in order to provide custodial or reporting services. They must maintain confidentiality of your information. This is only done for servicing our clients, and not for marketing purposes.</i> |
| Joint marketing | <p>A formal agreement between nonaffiliated financial companies that together market financial products or service to you.</p> <ul style="list-style-type: none">▪ <i>We do not jointly market.</i> |
