Updates to the Form ADV Part 3: Relationship Summary

Morningstar Investment Services renamed its investment advisory program from Morningstar® Managed PortfoliosSM program to the Morningstar Wealth Platform. In conjunction with this change, the service name Morningstar® Managed PortfoliosSM was retired. These updates were reflected throughout the Relationship Summary.

We updated *Relationships and Services* to include that, in addition to portfolios created by Morningstar Investment Management LLC, our direct parent, and portfolios based on indexes created by our ultimate parent, Morningstar, Inc., we are offering portfolios licensed from third-party advisory firms or based on the strategies of another investment adviser we retain under a sub-advisory agreement.

The Fees, Costs, Conflicts, and Standards of Conduct section was updated to note that our annual fee generally ranges from 0.05 - 0.70% per Portfolio and that the fee your Advisory Firm assesses is typically no more than 1.10%. This section was also updated to reflect that in addition to salary and bonus, in some cases, portfolio managers may also receive annual stock grants.

We made other edits where necessary to correct grammar or punctuation, to provide clarification or further information, for consistency in terminology or content, or to improve the readability of the brochure.
