| <b>Why can't I limit all sharing?</b>                  | Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>▪ sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>▪ affiliates from using your information to market to you</li> <li>▪ sharing for non-affiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p> |
| <b>Definitions</b>                                     |  |
| <b>Affiliates</b>                                      | Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ <i>Our affiliates include 3EDGE General Partner, LP</i></li> </ul>  |
| <b>Nonaffiliates</b>                                   | Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ <i>3EDGE does not share with non-affiliates so they can market to you.</i></li> </ul>   |
| <b>Joint Marketing</b>                                 | A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>▪ <i>3EDGE does not jointly market.</i></li> </ul>   |
