- Begin gathering employee census data and plan documentation.
- Understand your insurance carrier's deadlines (most renewals occur in Q4).
- Work with your advisor early to review new plan options and pricing.

- · Notify your CPA, legal counsel, and other key advisors of any structural shifts.
- Ensure benefits decisions are aligned with your tax and financial goals.
- Talk with your wealth advisor about how your benefit strategy supports business value and owner equity.

- Revisit your benefits strategy at least annually not just during renewal.
- · Align offerings with employee retention and recruitment goals.
- Bundle benefits planning with long-term financial and succession strategies.
