Investment Strategy

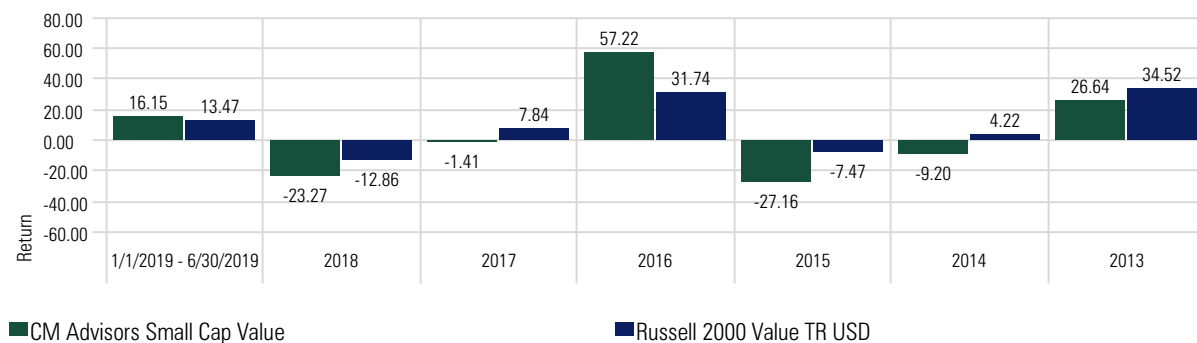
The investment seeks long-term growth of capital. The fund invests primarily in equity securities of small capitalization companies ("small cap") that the Advisor believes are undervalued. Under normal circumstances, at least 80% of the fund's net assets (including the amount of any borrowings for investment purposes) will be invested in small cap equity securities, which may include shares of other RICs, such as ETFs, that invest primarily in small cap equity securities. It typically invests in common stocks, although it may also invest in other equity securities.

The expense cap for the Fund contractually limits ordinary operating expenses to not more than 1.25% (exclusive of the Fund's Rule 12b-1 fees) of the average daily net assets of the CM Advisors Small Cap Value Fund until July 1, 2020. The Russell 2000 Value Index ADJ measures the performance of the small-cap value segment of the U.S. equity universe. It includes those Russell 2000 Index companies with lower price-to-book ratios and lower forecasted growth values. The Russell 2000 Value Index is constructed to provide a comprehensive and unbiased barometer for the small-cap value segment. The Index is completely reconstituted annually to ensure larger stocks do not distort the performance and characteristics of the true small-cap opportunity set and that the represented companies continue to reflect value characteristics. It is not possible to invest directly in the index.

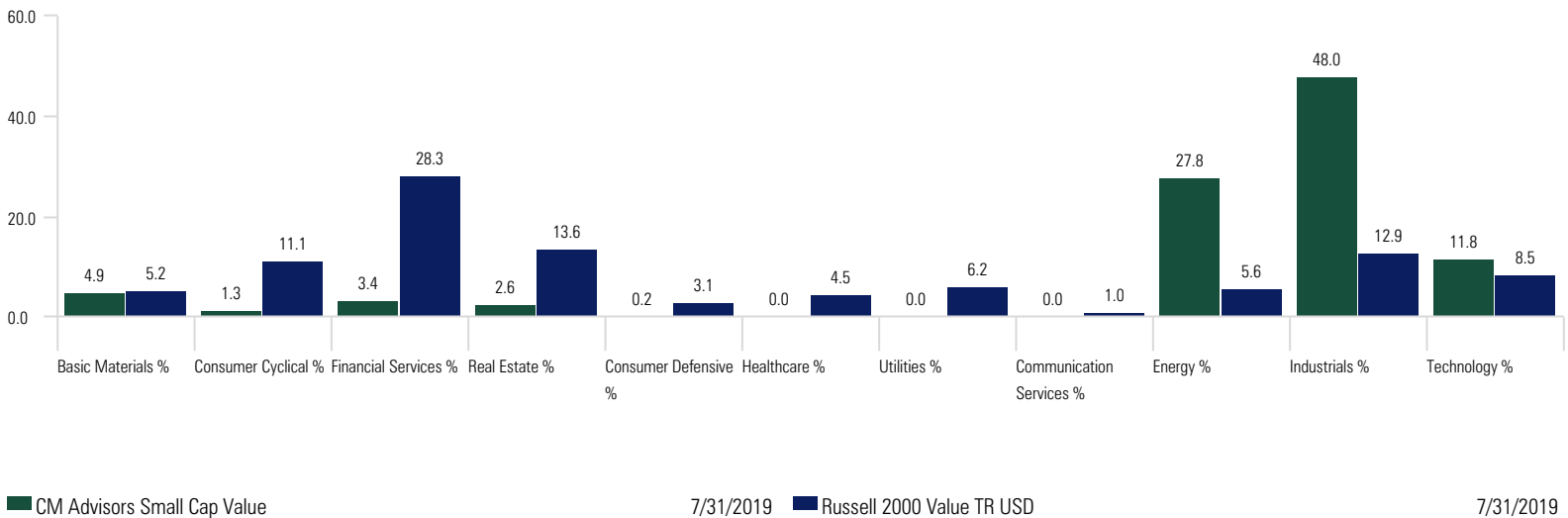

The **Average Market Cap** is an investment portfolio or stock market index weighted by the market capitalization of each stock in the portfolio or index. **Price-to-Prospective Earnings Ratio (Forward 1 Yr. P/E)** is a valuation ratio that compares a company's price to its forecasted earnings. **Price-to-Book Value (P/B)** is a ratio used to compare a stock's market value to its book value. **Price-to-Sales (P/S)** is a ratio used to compare a stock's market value to its sales per share. **Price-to-Cash Flow (P/C)** is a ratio used to compare a stock's market value to its cash flow per share. **Dividend Yield** is a financial ratio that shows how much a company pays out in dividends each year relative to its share price. **Potential Capital Gains Exposure** is an assessment of the extent to which the Fund has appreciated or depreciated, which may have tax implications for investors. **Alpha** is the excess return of the fund relative to the return of the benchmark index. **Beta** is a measure of the volatility, or systematic risk, of a security or a portfolio in comparison to the market as a whole. **R2 (R-Squared)** is a statistical measure that represents the percentage of a fund's movement that can be explained by movements in the benchmark index. **Tracking Error** is a divergence between the price behavior of a position or a portfolio and the price behavior of a benchmark. **Information Ratio** is a ratio of portfolio returns above the returns of a benchmark to the volatility of those returns. **Excess Return** is the investment returns from a security or portfolio that exceed a benchmark with a similar level of risk. **Standard Deviation** is a measure of the dispersion of a set of data from its mean. **Sharpe Ratio** is the average return in excess of the risk-free rate per unit of volatility or total risk. **Sortino Ratio** is a variation of the Sharpe ratio that differentiates harmful volatility from total volatility by using the asset's standard deviation of negative asset returns, called downside deviation.
