

**University of Cincinnati Retirement Plan Election  
Deadline - 2020 Hire/Eligibility Date**

From your initial date of hire you are assigned to one of the Ohio state retirement systems. Based on your job classification, you are assigned to the State Teachers Retirement System (STRS for faculty positions) or the Ohio Public Employees Retirement System (OPERS, for non-teaching positions). If you are a full-time employee (100% FTE) you may elect to contribute to the Alternative Retirement Plan (APR) instead of the state system. Prior to making your decision review the material available to you on the HR website at [www.uc.edu/hr/benefits/retirement](http://www.uc.edu/hr/benefits/retirement). You must submit a Retirement Plan Election Form regardless of your enrollment decision. Forms are available at [www.uc.edu/hr/forms](http://www.uc.edu/hr/forms). You must return your Retirement Plan Election form by 5:00 pm on the date shown below. Submit your completed form to the Human Resources Department, Mail Location 0039, or University Hall Suite 340.
