Students must pass a test composed of 30 questions right after completing each of the 11 modules before proceeding to the next module. Examination: The final exam consists of 90 questions, and students are given three hours to take it. At least 70% of correct answers students should have to get for them to graduate. Continuing Education: To maintain authorized use of the credential, designees are required to complete 16 continuing education credits* every two years with any CE provider. Ongoing CE maintains the credibility of our credentials, ensuring designees are knowledgeable on current industry trends in the financial market. The Standards of Professional Conduct establishes minimum standards of acceptable professional conduct for persons authorized to use one of the professional designations.
