

# PRIVACY POLICY GDPR

We at Avrio Wealth Pte Ltd ("Avrio"," "we," "us," or "our") have created this privacy policy (this "Privacy Policy") because we know that you care about how information you provide to us is used and shared. This Privacy Policy relates to our information collection and use of your information through our website located at <a href="https://avriowealth.com/">https://avriowealth.com/</a> (the "Site").

By visiting our Site, you are agreeing to the terms of this Privacy Policy and the accompanying Terms of Use. #### The Information We Collect and/or Receive

#### **GDPR** Disclosure

**Legal Basis and Purpose:** Avrio acts as "data controller" of the Contact Information and Other Information collected on the Site for the purposes and under the legal bases described below:

  agreements and our legitimate interest in providing investment research materials to interested EEA
  Individuals. Note that EEA Individuals must affirmatively sign up to receive such materials. Such

- Other Information: We collect Other Information so that individuals can connect and use the Site, and to maintain security audit logs to remove or defend against malicious visitors or attackers (e.g., thwarting DDOS attacks). This information is logged internally within the web servers that host our Site and stored on an ongoing basis.
